ERV Award - The chapter is making a new presentation this year in recognition of the service and sacrifice that two individuals continue to make. It is necessary for them to stop their lives on a dime and be ready to answer National's call to transport the National ERV to a disaster within 4 hours of being called. It is with our deep appreciation that we recognize Ken Chapin and Butch Clinton with the ERV Award.



Partnership Award - Since the early 90's the Indian River County Recreation Department has been providing American Red Cross water safety programs in several locations. These programs include water safety instructor classes for those adults who will teach swim lessons to student's age 6 months to adult. In addition they train the lifeguards for pools and beaches in the county. One of their newer programs is a Junior Lifeguard program which trains 11 to 14 year olds to be Junior Lifeguards. This program teaches water safety, first aid techniques, builds self-confidence and helps prepare interested youths for work as lifeguards. Participants learn about beach safety in a fun and challenging atmosphere. This year they will be training over 50 young people. We thank them for their support of the American Red Cross life-saving programs.



DAT Award - Walter Miller A member of the North Treasure Coast Chapter of the American Red Cross for several years. Walter lives in Fort Pierce and is active throughout the community. He is the Co-Captain of Team II, St. Lucie County Disaster Action Team and has served in this capacity since joining the Chapter. Walter is a dedicated and dependable service associate who enjoys helping others in time of need and has been recognized by many who have been assisted by him. ## Clara Barton Volunteer Leadership Honor Award

Ray McGowan – Ray first came to the North Treasure Coast Chapter with a contribution for the tsunami. IN 2006, thanks to the McGowan's support among others, the chapter was able to purchase an ERV, the Expedition and two storage trailers for disaster response. Ray joined the board in July of 2006 and was soon deeply involved in our issues, including chairing the Service Delivery Committee as well as working with the staff on facilities needs. Always active in the board meetings, Ray began to spend time with the staff to understand the real issues within the chapter. In the spring of 2007, Ray challenged the chapter to raise half of the funds to improve our infrastructure at which time he would match the funds raised. We were able to raise more than \$300,000, balance the annual budget, equip the chapter with everything needed and even added a pick-up truck to pull the trailers! When he became Chair, Ray challenged the volunteers to support the chapter monetarily with the "Make Ray Pay" Campaign. Over the last two years this matching campaign has raised more than \$27,000 and he has agreed to do it again in FY10! As chair-elect and Chair, Ray has been there for every board event, every volunteer event, every regional meeting and any other time I have needed him. Nothing points this out more than our response to Tropical Storm Fay. Ray was here from the beginning, right through our after-action meeting. He rode the ERV, ordered pizza, delivered cots, manned the phones, met with volunteers and emptied trash. His observations about our processes will serve us well in our next response. All this from a man who responded on his Board intake form that he was NOT interested in Disaster! As Ray's term as Board Chair comes to an end tonight, it gives me great pleasure to present him with the Clara Barton Volunteer Leadership Honor Award. The criteria for the award is as follows:

- Service in a number of leadership positions and personal expertise that has enabled the Red Cross to contribute valuable service to the community.
- Leadership in identifying and assessing volunteer performance and organizational concerns. Cooperation with other paid and volunteer staff in developing and implementing effective solutions in a resourceful and productive manner.
- Constructive guidance to co-workers in the efficient performance of assignments.

Ray joins only three others who have received this award from the North Treasure Coast Chapter. He is one in a million and a true friend to all of us who have worked with him on a regular basis. Please join me in thanking him for all he has done for our American Red Cross.
